Get Encrypted Payment

Overview

The Payment Data Access service is an API that retrieves credit card and ACH entries from the Sage payment vault and returns the data in a user encrypted format. It is licensed for one-year of unlimited use only to Sage Development Partners.

Format

GetEncryptedCard(*GUID\$,LicenseKey\$,CompanyCode\$,PaymentType\$,EncryptedCard\$*)

GetEncryptedCard(*GUID\$,LicenseKey\$,MID\$,MKEY\$,EncryptedCard\$*)

Where:

<i>GUID\$</i>	This is the CreditCardGUID\$
<i>LicenseKey\$</i>	MBA's License Key. This will be provided by MBA after it has been purchased. License keys are based on the Sage Serial number and is good for one year.
<i>CompanyCode\$</i>	Company code is the three-digit company code in Sage.
<i>MID\$</i>	MID is the Merchant ID (AR_PaymentType.MerchantID\$) or Vault Only ID (sy_company.CreditCardVaultOnlyID\$) that the GUID is based on.
<i>PaymentType\$</i>	PaymentType is the paymentType value in Sage related to the GUID. *This is required if using CompanyCode\$.
<i>MKEY\$</i>	MKEY is the Merchant Key (AR_PaymentType.MerchantKey\$) or Vault only Key (sy_company.CreditCardVaultOnlyKey\$) that the GUID is based on. *This is required if using MID\$.
<i>EncryptedCard\$</i>	This is the variable that the encrypted payment information is passed to. It is Encrypted with Alogrithm of AES using Cipher mode CBC with a length of 256. When decrypted the value will be an array containing either the Credit Card or ACH data. The layout would be:

- **ChilkatCrypt2.dll** - Chilkat encrypt/decrypt
- **SY_ccExport.PVC** - Object that contains the function being called to get data.
